

IRREVOCABLE POWER OF ATTORNEY*(BLUE COMPASS S.R.L.)*

The undersigned:

BLUE COMPASS S.R.L., a company incorporated under the laws of Romania, having its seat and business address at (400073) Amos Frâncu nr. 1-3, ap. 1, Cluj-Napoca, Romania, registered in the trade register of Romania under number J12/3828/2020, hereinafter referred to as: the "**Grantor**",

herewith declares:

- a. to give an irrevocable power of attorney to each civil law notary, deputy civil law notary, notarial secretary and any employee working at Elements Legal N.V., hereinafter referred to as: the "**Attorneys**", acting jointly as well as severally and with full power of substitution, on behalf of the undersigned:
 - to resolve on, to approve, to sign, to execute, to deliver and to ratify any and all resolutions, documents, agreements, deeds, certificates and instruments, as well as to perform all obligations, acts and things in connection with or conducive to the issuance of five thousand (5,000) shares in the share capital of Coera Holding B.V. to the Grantor against contribution of shares in the share capital of the Grantor hereinafter referred to as: the "**Issuance**", among which:
 - to execute the deed of issuance of shares in the capital of Coera Holding B.V. with document number 20200155.05 and all documents related and/or conducive thereto;
 - to register any changes relating to the Issuance with the Trade Register of the Dutch Chamber of Commerce;
 - to duly act, in the name and on behalf of the undersigned, and as such to be solely and fully authorized to take any action and to execute and deliver any forms, certificates, instruments or other documents, as the Attorneys may deem necessary, appropriate or expedient to put into effect the foregoing, and furthermore to perform all transactions contemplated by and pursuant thereto, and anything else which the Attorneys deem necessary in order to carry out the purposes and the intent of the above;
 - to perform all other (legal) acts and to deliver all other related documents as the Attorneys may deem necessary, appropriate or expedient to put into effect the Issuance and furthermore to do anything else which the Attorneys will deem necessary in order to carry out the purposes and the intent of the foregoing;
- b. to irrevocably and unconditionally indemnify the Attorneys against all costs, expenses, claims and liabilities, incurred by any of them as a result of the exercise in good faith of the authority conferred by this irrevocable power of attorney. The aforesaid costs, expenses, claims and liabilities shall include all costs, expenses, claims and liabilities incurred in relation to the defence of such claim;
- c. to ratify and to confirm all that the Attorneys or their substitute(s) shall lawfully do or cause to be

done by virtue of this document; and

- d. to approve that the Attorneys shall also be authorized to act as the attorney of the undersigned counterparty ("*Selbsteintritt*"), to the extent applicable.

Each signatory may deliver a signed copy of this power of attorney by e-mail and any such e-mailed copy shall be deemed to be an original for all purposes.
